

R E S O L U T I O N

WHEREAS, various sections of TITLE 11 of the Las Vegas Municipal Code allow for additions to and corrections of the schedules which are established in the respective sections to be effected by Resolution; and

WHEREAS, it has been determined and recommended by the Traffic and Parking Commission and the Traffic Engineer that the following additions and corrections be made in said schedules; and

NOW, THEREFORE, be it resolved by the City Council of the City of Las Vegas, Nevada, that the following schedules pertaining to TITLE 11 of the City Code be amended as follows:

Schedule 3-I be amended to include the following Parking Meter Zone:

On the east side of Seventh Street from Ogden Avenue to Stewart Avenue

On the north side of Fremont Street from Fourth Street to 105' west of Las Vegas Boulevard

Schedule 3-I be amended to delete the following Parking Meter Zone:

On the north side of Fremont Street from Fourth Street to 115' east of Fourth Street

On the north side of Fremont Street from 170' east of Fourth Street to 105' west of Las Vegas Boulevard

Schedule 17-III be amended to include the following No Parking Anytime Zone:

On the north side of Presidio Avenue from the alley east of Westwood Drive to Highland Drive

On both sides of Westcliff Drive from Buffalo Drive to Lorenzi Boulevard



On both sides of Arville Street from Sirius Avenue to Sahara Avenue

On both sides of Bonanza Road from Bonanza Road to Wilson Avenue

On the south side of Westcliff Drive from Durango Drive to Buffalo Drive

Schedule 17-III be amended to delete the following No Parking Anytime Zone:

On the east side of Arville Street from Sirius Avenue to Pennwood Avenue

On the east side of Las Vegas Boulevard from Bonanza Road to 90' south of Wilson Avenue

On the south side of Westcliff Drive from 400' west of Rainbow Boulevard to Lorenzi Boulevard

Schedule 17-IV be amended to delete the following No Parking Certain Hours Zones:

On the north side of Fremont Street from 115' east of Fourth Street to 170' east of Fourth Street

Schedule 17-VI be amended to include the following Time Limited Parking Zone:

On the east side of Seventh Street from Gass Avenue to 165' north (2)

Schedule 17-VI be amended to delete the following Time Limited Parking Zone:

On the north side of Presidio Avenue from the alley east of Westwood Drive to Highland Drive


Schedule 18-III be amended to include the following 15 Minute Loading Zone:

On the north side of Boulder Avenue from Main Street to First Street

Schedule 18-V be amended to delete the following 30 Minute Commercial Loading Zone:


On the north side of Fremont Street from 115' east of Fourth Street to 170' east of Fourth Street
