

1 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
2 LAS VEGAS, NEVADA, TO ESTABLISH A COMMUNITY  
3 PARTICIPATION PLAN AND APPLICATION PROCESS FOR THE  
4 SEVENTEENTH YEAR (1991-92) COMMUNITY DEVELOPMENT  
5 BLOCK GRANT PROGRAM

6 WHEREAS, the City of Las Vegas intends to submit an application  
7 for Seventeenth Year (1991-92) Community Development Block Grant funds under  
8 Title I of the Housing and Community Development Act of 1974 (P.L. 93-383) as  
9 amended; and

10 WHEREAS, said City desires to insure that its residents are  
11 afforded complete information on funding available, eligible activities, and  
12 possible program directions; and

13 WHEREAS, said City desires to insure adequate representation of  
14 community organizations, groups and individuals in the public services  
15 application development process; and

16 WHEREAS, the Department of Economic & Urban Development of said  
17 City provides information to citizens on the Community Development Block  
18 Grant Program, the meetings and functions of the citizen participation  
19 process, and the application process; and

20 WHEREAS, said City recognizes that citizen input is necessary for  
21 the development of the application process and the determination of program  
22 priorities; and

23 WHEREAS, said City and Clark County may desire to undertake  
24 certain community development improvements within the City limits of said  
25 City in the furtherance of the Community Development Block Grant funding  
26 activities; and

27 WHEREAS, the City desires to continue the City's policy of  
28 providing \$350,000 in CDBG resources for rehabilitation of substandard  
29 housing for neighborhood revitalization that provides or maintains affordable  
30 housing for large families, disable individuals, and other special needs  
31 categories; and

32 WHEREAS, said City desires that citizens have an opportunity to  
participate in the development of the Final Statement prior to its submission  
to the Department of Housing and Urban Development (HUD).

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Las Vegas:

1. That a community participation plan and application process be developed for the Seventeenth Year Community Development Block Grant Program.

2. That the Department of Economic & Urban Development of said City shall be responsible for the development, publication and administration of the citizens participation plan and application process.

3. That the citizen participation process shall include at least one public meeting or hearing as required by HUD regulations.

4. That the Citizen Participation Plan shall include a timetable and shall provide a brief description of each public meeting or hearing.

5. That the citizen participation process shall commence in November, 1990, and shall continue until the submission of the Seventeenth Year (1991-92) Community Development Block Grant application to the U. S. Department of Housing and Urban Development (HUD).

6. That, commencing with the adoption of this Resolution, participation in the community participation process shall be opened to the general public, any individual or representative of any group or organization within said City that decides to be part of said process.

7. An informational campaign shall be initiated by the said Department of Economic & Urban Development that shall include public service announcements to inform citizens of the aforementioned process.

8. Said Department of Economic & Urban Development will provide staff resources throughout this process for the purpose of providing all relevant information on the Community Development Block Grant application process.
