

RESOLUTION ACCEPTING BIDS

WHEREAS, the City Council of the City of Las Vegas, in the County of Clark and State of Nevada, has taken steps to create certain public improvements within said City, all as designated as Las Vegas Special Improvement District No.

462; and

WHEREAS, by resolution passed, adopted and approved on the 19th day of September, 1990, the City Clerk was directed to publish notice of the receipt of bids for the furnishing of labor, materials, transportation and services for the improvements to be installed in each assessment unit of said Special Improvement District No. 462; and

WHEREAS, proper notices were given by publication of the receipt of bids for the furnishing of such labor, materials, transportation and services; and

WHEREAS, bids were received and opened on the 13th day of November, 1990, and confirmation thereof was continued for the purpose of tabulating and reporting the same to said City Council; and

WHEREAS, the time has now arrived to award the construction contract in each of the individual assessment units of said District, all in accordance with Chapter 271 of the Nevada Revised Statutes;


