

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
LAS VEGAS, NEVADA, TO ESTABLISH A COMMUNITY
PARTICIPATION PLAN AND APPLICATION PROCESS FOR THE
EIGHTEENTH YEAR (1992-93) COMMUNITY DEVELOPMENT
BLOCK GRANT PROGRAM

WHEREAS, the City of Las Vegas intends to submit an application for Eighteenth Year (1992-93) Community Development Block Grant (CDBG) funds under Title I of the Housing and Community Development Act of 1974 (P.L. 93-383) as amended; and

WHEREAS, said City desires to insure that its residents are afforded complete information on funding available, eligible activities, and possible program directions; and

WHEREAS, said City desires to insure adequate representation of community organizations, groups and individuals in the public services application development process; and

WHEREAS, the Department of Economic & Urban Development of said City provides information to citizens on the Community Development Block Grant Program, the meetings and functions of the citizen participation process, and the application process; and

WHEREAS, said City recognizes that citizen input is necessary for the development of the application process and the determination of program priorities; and

WHEREAS, said City and Clark County may desire to undertake certain community development improvements within the City limits of said City in the furtherance of the Community Development Block Grant funding activities; and

WHEREAS, the City desires to provide \$350,000 in CDBG funds to support its housing strategy as outlined in the City's FY92 Comprehensive Housing Affordability Strategy (CHAS) which will provide or maintain affordable housing for very low, low and moderate families, disabled individuals, and people with special needs; and

WHEREAS, the City desires to complete the FY91 capital projects Cannon Center, West Las Vegas Cultural Arts Center, Salvation Army Day

1 Center, and has dedicated FY92 CDBG funds to complete these projects before
2 new capital projects are funded; and

4 WHEREAS, said City desires that citizens have an opportunity to
5 participate in the development of the CDBG Final Statement prior to its
6 submission to the Department of Housing and Urban Development (HUD).

7 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of
8 Las Vegas:

9 1. That a community participation plan and application process
10 be developed for the Eighteenth Year Community Development Block Grant
11 Program.

12 2. That the Department of Economic & Urban Development of said
13 City shall be responsible for the development, publication and administration
14 of the citizens participation plan and application process.

15 3. That the City Council citizen participation process include
16 at least one public meeting or hearing as required by HUD regulations.

17 4. That the Citizen Participation Plan shall include a
18 timetable and shall provide a brief description of each public meeting or
19 hearing.

20 5. That the citizen participation process shall commence in
21 February, 1992, and shall continue until the submission of the Eighteenth
22 Year (1992-93) Community Development Block Grant application to the U. S.
23 Department of Housing and Urban Development (HUD).

24 6. That, commencing with the adoption of this Resolution,
25 participation in the community participation process shall be opened to the
26 general public, any individual or representative of any group or organization
27 within said City that decides to be part of said process.

28 7. An informational campaign shall be initiated by the said
29 Department of Economic & Urban Development that shall include public service
30 announcements to inform citizens of the aforementioned process.

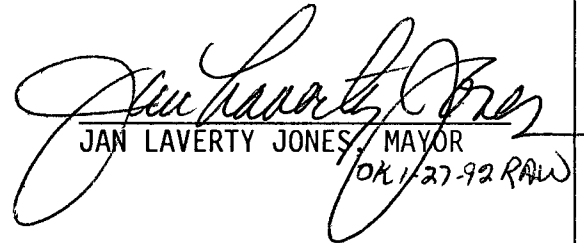
31 8. Said Department of Economic & Urban Development will
32 provide staff resources throughout this process for the purpose of providing

1 all relevant information on the Community Development Block Grant application
2 process.

4 9. That the funding of the City of Las Vegas Community
5 Development Block Grant Housing Strategy to support the Comprehensive Housing
6 Affordability Strategy (CHAS) be allocated at no less than Three Hundred
7 Fifty Thousand (\$350,000) Dollars.

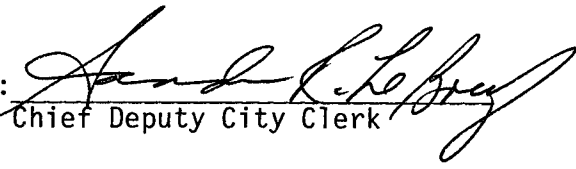
