

1 A RESOLUTION OF THE CITY COUNCIL OF THE
2 CITY OF LAS VEGAS DECLARING THAT A STATE OF
3 EMERGENCY EXISTS WITHIN SAID CITY AND DIRECTING
4 THE ACTIVATIION OF SAID CITY'S
5 EMERGENCY MANAGEMENT PLAN

6 WHEREAS, the City Council of the City of Las Vegas has
7 been informed that civil disorder in the form of rioting,
8 looting, violence, and other public disturbances exist within
9 said City; and

10 WHEREAS such civil disorder represents a disaster
11 emergency and is a substantial and imminent peril to said City
12 and to the residents thereof and the property therein; and

13 WHEREAS, the City Council of said City hereby finds that
14 it will be necessary to take appropriate action as further evi-
15 denced by the Proclamation Disaster Emergency signed by the City
16 Manager, William J. Noonan, dated April 30, 1992, to protect the
17 public peace, health and safety, and to preserve the lives and
18 property, of the residents of said City; and

19 WHEREAS, in light of the exigencies of this disaster
20 emergency, said City Council further finds that it will be
21 necessary to take such action without regard to the formalities
22 which are prescribed by law.

23 NOW, THEREFORE, BE IT RESOLVED AND DECLARED by the City
24 Council of the City of Las Vegas that a state of emergency exists
25 as of 7:00 p.m. on Friday, May 1, 1992, to 7:00 a.m. on Saturday,
26 May 2, 1992, within said City; and

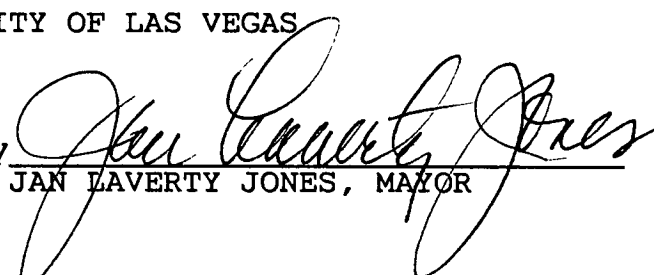
27 IT IS THEREFORE ORDERED that the Coordinator of
28 Emergency Operations of said City be, and he hereby is,
authorized, empowered and directed to activate said City's



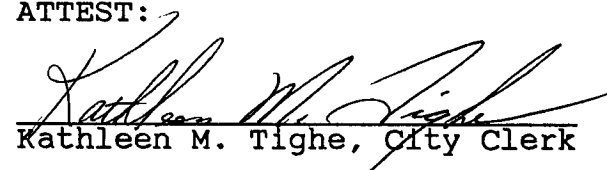
1 Emergency Management Plan, and he is further authorized,
2 empowered and directed to undertake such emergency management
3 operations and to take such other and further actions as may be
4 necessary or appropriate in order to respond to such emergency
5 and to implement the provisions of said plan.
