

R E S O L U T I O N

WHEREAS, various sections of TITLE 11 of the Las Vegas Municipal Code allow for additions to and corrections of the schedules which are established in the respective sections to be effected by Resolution; and

WHEREAS, it has been determined and recommended by the Traffic and Parking Commission and the Traffic Engineer that the following additions and corrections be made in said schedules;

NOW, THEREFORE, be it resolved by the City Council of the City of Las Vegas, Nevada, that the following schedules pertaining to TITLE 11 of the City Code be amended as follows:

Schedule 17-III be amended to include the following No Parking Anytime Zone:

On the north side of Meadows Lane from Decatur Boulevard to 500' east of Decatur Boulevard.

On the north side of Meadows Lane from 500' east of Decatur Boulevard to 530' east of Decatur Boulevard (trolleys exempted)

On the north side of Meadows Lane from 530' east of Decatur Boulevard to 1260' east of Decatur Boulevard.

On the north side of Meadows Lane from 1260' east of Decatur Boulevard to 1300' of Decatur Boulevard (trolleys exempted)

On the north side of Meadows Lane from 1300' east of Decatur Boulevard to Valley View Boulevard.

On the north side of Fremont Street from 15th Street to 70' east of 15th Street (trolleys exempted)

On the north side of Fremont Street from 100' west of Bruce Street to Bruce Street (trolleys exempted)

On the south side of Fremont Street from 85' west of Bruce Street to Bruce Street.

On the east side of Bruce Street from Lewis Avenue to 40' north of Lewis Avenue (trolleys exempted)

On the east side of Bruce Street from 40' north of Lewis Avenue to Circle Drive.

Schedule 17-III be amended to delete the following No Parking Anytime Zone:

On the north side of Meadows Lane from Decatur Boulevard to Valley View Boulevard.

On the east side of Bruce Street from Lewis Avenue to Circle Drive.

Schedule 17-VI be amended to include the following Time Limited Parking Zone:

On the north side of Fremont Street from 70' east of 15th Street to 1621 Fremont Street.

On the north side of Fremont Street from 1621 Fremont Street to 100' west of Bruce Street.

On the south side of Fremont Street from 1621 Fremont Street to 85' west of Bruce Street.



On the west side of 8th Street from 100' south of Gass Avenue to Gass Avenue.

Schedule 17-VI be amended to delete the following Time Limited Parking Zone:

On the north side of Fremont Street from 15th Street to 1621 Fremont Street.

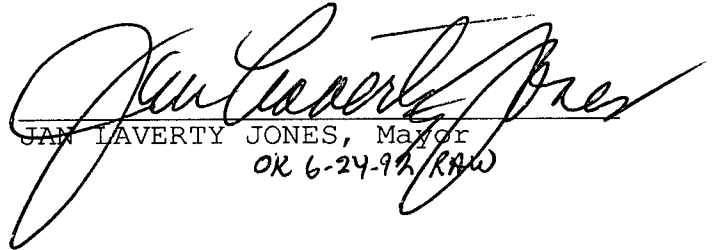
On both sides of Fremont Street from 1621 Fremont Street to Bruce Street.

On the south side of Fremont Street from 1621 Fremont Street to Bruce Street.

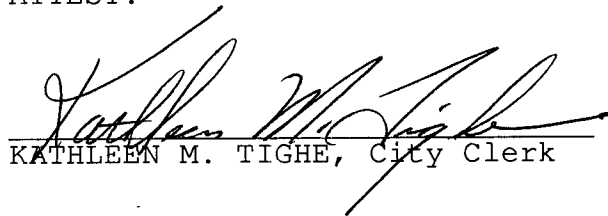
Schedule 17-VII be amended to include the following Handicapped Parking Space:

On the south side of Gass Avenue from 160' west of 8th Street to 115' west of 8th Street.
