

RESOLUTION NO. R-15-93

A RESOLUTION CONSENTING TO THE BORROWING OF MONEY AND ISSUING OF GENERAL OBLIGATION BONDS BY THE LAS VEGAS METROPOLITAN POLICE DEPARTMENT FOR THE PURPOSE OF CONSTRUCTING BUILDINGS AND IMPROVING PROPERTY USED BY THE DEPARTMENT.

WHEREAS, the Las Vegas Metropolitan Police Department (the "Department") is organized and existing under the provisions of Chapter 280 of NRS; and

WHEREAS, the Department has received approval from the Clark County General Obligation Bond Commission to submit to the registered voters of the taxing district of the Department as defined in NRS 280.262, the bonds described in the following proposal:

GENERAL OBLIGATION (LIMITED TAX) METROPOLITAN POLICE BOND PROPOSAL:

Shall the Las Vegas Metropolitan Police Department be authorized to incur a general obligation indebtedness by the issuance at one time, or from time to time, of the Department's general obligation metropolitan police bonds in one series or more, in an aggregate principal amount not to exceed \$24,000,000 to defray wholly or in part the cost of constructing buildings and improving property used by the department, including, without limitation, area command police stations and all appurtenances, equipment, furnishings and incidentals necessary, useful or desirable thereto, such bonds to mature serially commencing not later than five (5) years from the date or respective dates of the bonds and ending not later than thirty (30) years therefrom, to be payable from general (ad valorem) taxes and to be issued and sold at, above, or below par at an effective interest rate (including any sale discount) not exceeding the statutory maximum rate, if any, as shall be determined at the time of the sale thereof, and otherwise to be issued in such manner, upon such terms and conditions, with such covenants and agreements, and with such detail as the Department may determine, including at its option

but not necessarily limited to provisions for the redemption of bonds prior to maturity without or with the payment of a premium?

(the "Proposal"); and

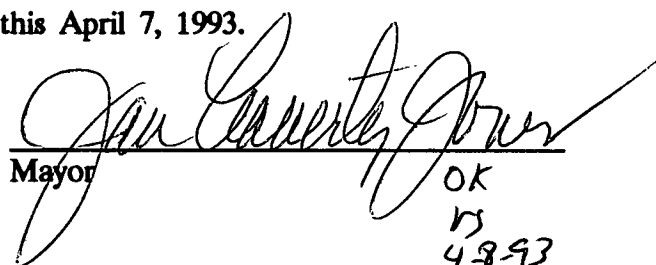
WHEREAS, pursuant to NRS 280.264, the Metropolitan Police Committee on Fiscal Affairs (the "Committee") has, subject to the consent of Clark County, Nevada (the "County") and the City of Las Vegas (the "City"), authorized and called a special bond election to be held on June 8, 1993, for the purpose of authorizing the Committee to borrow money and issue general obligation bonds on behalf of the Department in order to construct buildings and improve property used by the Department (the "Bonds" and the "Project"), as described in the Proposal.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Las Vegas, Nevada.

Section 1. Subject to the approval by the registered voters of the taxing district of the Department as defined in NRS 280.262, the City Council of the City of Las Vegas, Nevada, does hereby consent to the borrowing of money and issuance of the Bonds by the Committee for purpose of the Project, as specified in the Proposal.

Section 2. This resolution is effective upon passage and approval.

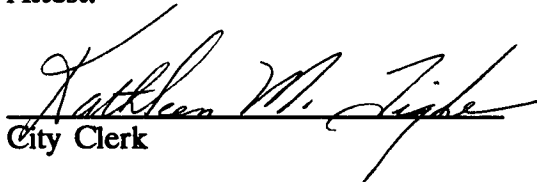

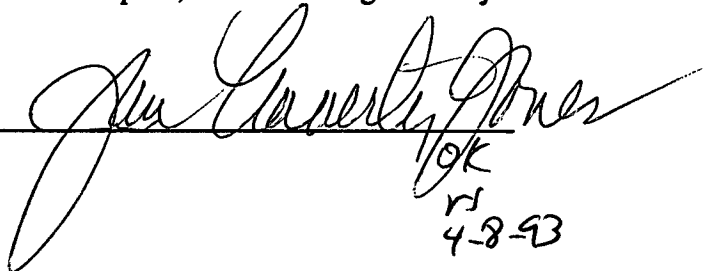

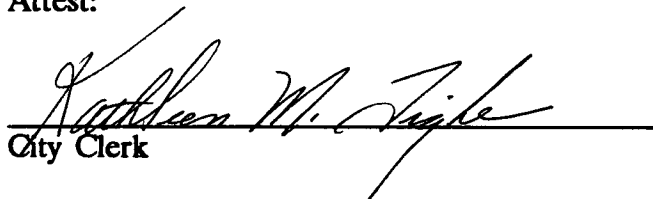
Thereupon, after considering other matters not concerning the proposed general obligation bonds, upon motion duly made and adopted, such meeting was adjourned.
