R E S O L U T I O N

WHEREAS, various sections of TITLE 11 of the Las Vegas Municipal Code allow for additions to and corrections of the schedules which are established in the respective sections to be effected by Resolution; and

WHEREAS, it has been determined and recommended by the Traffic and Parking Commission and the Traffic Engineer that the following additions and corrections be made in said schedules;

NOW, THEREFORE, be it resolved by the City Council of the City of Las Vegas, Nevada, that the following schedules pertaining to TITLE 11 of the City Code be amended as follows:

Schedule 3-I be amended to include the following Parking Meter Zones:

On the west side of 3rd Street from 240' north of Bridger Avenue to 260' north of Bridger Avenue

On the west side of 3rd Street from 285' north of Bridger Avenue to Carson Avenue

Schedule 3-I be amended to delete the following Parking Meter Zones:

On the west side of 3rd Street from 195' north of Bridger Avenue to 160' south of Carson Avenue

On the west side of 3rd Street from 135' south of Carson Avenue to 65' south of Carson Avenue

Schedule 14-II be amended to include the following Stop Signs:

On both sides of Ducharme Avenue at Cimarron Road

Schedule 14-II be amended to delete the following Stop Signs:

On both sides of Cimarron Road at Ducharme Avenue

Schedule 17-III be amended to include the following No Parking Anytime Zones:

On the west side of 3rd Street from Bridger Avenue to 175' north

On the west side of 3rd Street from 260' north of Bridger Avenue to 285' north of Bridger Avenue

Schedule 17-III be amended to delete the following No Parking Anytime Zones:

On the west side of 3rd Street from Bridger Avenue to 50' north



On the west side of 3rd Street from 50' north of Bridger Avenue to 80' north of Bridger Avenue (Trolleys excepted)

On the west side of 3rd Street from 80' north of Bridger Avenue to 175' north of Bridger Avenue

On the west side of 3rd Street from 160' south of Carson Avenue to 135' south of Carson Avenue

Schedule 17-VII be amended to include the following Handicapped Parking Zone:

On the west side of 3rd Street from 175' north of Bridger Avenue to 215' north of Bridger Avenue

Schedule 17-VII be amended to delete the following Handicapped Parking Zone:

On the west side of 3rd Street from 65' south of Carson Avenue to Carson Avenue

Schedule 18-III be amended to include the following 15 Minute Loading Zone:

On the west side of 3rd Street from 215' north of Bridger Avenue to 240' north of Bridger Avenue

Schedule 18-III be amended to delete the following 15 Minute Loading Zone:

On the west side of 3rd Street from 175' north of Bridger Avenue to 195' north of Bridger Avenue
