

R E S O L U T I O N

WHEREAS, the City Council of the City of Las Vegas pursuant to a Resolution dated June 1, 1977 adopted that publication entitled, to-wit: "The Uniform Standard Specifications for Public Works' Construction Off-Site Improvements, Clark County Area, 1977" (hereinafter referred to as the "Uniform Standard Specifications") in order to assure the construction of standardized public work facilities throughout Clark County; and

WHEREAS, a Revision Committee composed of representatives from the various governmental entities within the County of Clark, State of Nevada periodically reviews the Uniform Standard Specifications in order to update and revise the provisions contained therein; and

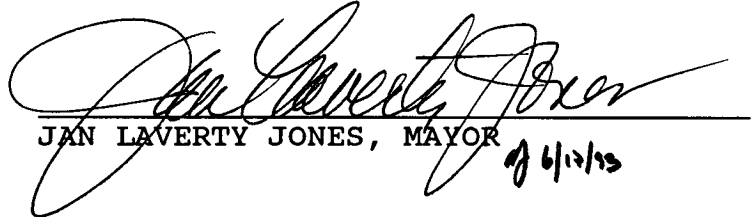

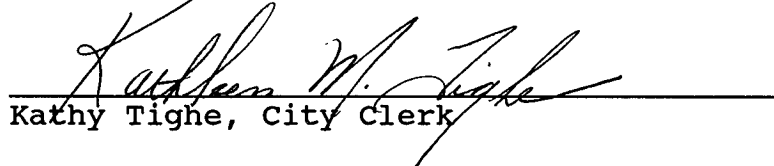
