**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAS VEGAS TO SUPPORT
THE ESTABLISHMENT OF A SOUTHERN NEVADA ENTERPRISE COMMUNITY**

WHEREAS, the Omnibus Budget Reconciliation Act of 1993 (**ACT**) has been signed into law by President William F. Clinton; and

WHEREAS, pursuant to Title XIII, Chapter I of the **ACT**, areas can be nominated for designation as empowerment zones, enterprise communities, and rural development investment areas by the Secretary of the United States Department of Housing and Urban Development (HUD) for urban zones and the United States Secretary of Agriculture for rural zones; and

WHEREAS, said designation may be made pursuant to Section 1391 (c) of the **ACT**, on a competitive basis, only after 1993 and before 1996; and

WHEREAS, the City of Las Vegas, in conjunction with the State of Nevada, Clark County, and the City of North Las Vegas, desires to apply to HUD to have an area within Clark County designated an enterprise community; and

WHEREAS, the City of Las Vegas needs to enter into an Interlocal Cooperative Agreement with the State of Nevada, Clark County, and the City of North Las Vegas in order to jointly submit an application for such designation; and

WHEREAS, upon the designation of an area within Clark County as an enterprise community, the City of Las Vegas, in conjunction with the State of Nevada, Clark County, and the City of North Las Vegas, and pursuant to the herein referenced Interlocal Cooperative Agreement, shall establish the "Southern Nevada Enterprise Community."



NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Las Vegas;

1. The Department of Economic and Urban Development (DEUD), on behalf of the City of Las Vegas, is hereby authorized to work with representatives of the State of Nevada, Clark County, and the city of North Las Vegas to agree on the terms and conditions for an Interlocal Cooperative Agreement to jointly submit an application for an enterprise community designation to HUD and to establish and manage the "Southern Nevada Enterprise Community";

2. That the Mayor of the City of Las Vegas is authorized to execute, on behalf of the City, the Interlocal Cooperative Agreement and any and all contracts and/or certifications required to apply for an Enterprise Community Designation.

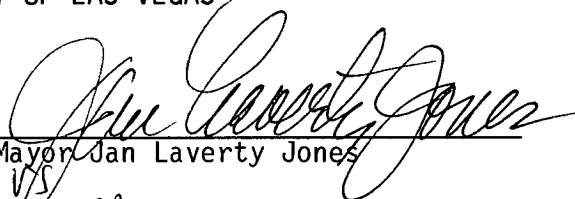
