

R E S O L U T I O N

WHEREAS, various sections of TITLE 11 of the Las Vegas Municipal Code allow for additions to and corrections of the schedules which are established in the respective sections to be effected by Resolution; and

WHEREAS, it has been determined and recommended by the Traffic and Parking Commission and the Traffic Engineer that the following additions and corrections be made in said schedules;

NOW, THEREFORE, be it resolved by the City Council of the City of Las Vegas, Nevada, that the following schedules pertaining to TITLE 11 of the City Code be amended as follows:

Schedule 17-III be amended to delete the following No Parking Anytime Zones:

On the east side of 4th Street between 90' south of Bridger Avenue and 65' south of Bridger Avenue (Trolleys Excepted).

On the east side of 4th Street between 65' south of Bridger Avenue and Bridger Avenue.

On the east side of 4th Street between Carson Avenue and 65' north of Carson Avenue.

On the east side of 4th Street between 110' south of Bridger Avenue and 90' south of Bridger Avenue.

Schedule 17-III be amended to include the following No Parking Anytime Zones:

On the east side of 4th Street between Bridger and 150' north of Fremont Street.

On the east side of 4th Street between 150' north of Fremont Street and 210' north of Fremont Street (Buses Excepted).

On the east side of 4th Street between 210' north of Fremont Street and Stewart Avenue.

On the west side of 4th Street between 245' north of Carson Avenue and 210' north of Fremont Street.

On the west side of 4th Street between 210' north of Fremont Street and 250' north of Fremont Street (Trolleys Excepted).

On the west side of 4th Street between 250' north of Fremont Street and 70' north of Ogden Avenue.

On the west side of 4th Street between 180' north of Ogden Avenue and Stewart Avenue.

On the west side of 4th Street between Bonneville Avenue and 65' north of Bonneville Avenue.

On the west side of 4th Street between 175' north of Bonneville Avenue and 300' north of Bonneville Avenue.

On the west side of 4th Street between 370' north of Bonneville Avenue and Clark Avenue.

On the east side of 4th Street between Bonneville Avenue and 200' north of Bonneville Avenue (Buses Excepted).

On the east side of 4th Street between 200' north of Bonneville Avenue and 275' north of Bonneville Avenue.

On the east side of 4th Street between 365' north of Bonneville Avenue and Clark Avenue.

On the west side of 4th Street between Clark Avenue and 65' north of Clark Avenue.

On the west side of 4th Street between 110' north of Clark Avenue and Lewis Avenue.

On the east side of 4th Street between Clark Avenue and 200' north of Clark Avenue.

On the east side of 4th Street between 425' north of Clark Avenue and 480' north of Clark Avenue.

On the east side of 4th Street between Lewis Avenue and 100' north of Lewis Avenue.

On the east side of 4th Street between 100' north of Lewis Avenue and Bridger Avenue (Buses Excepted).

On the west side of 4th Street between Lewis Avenue and 60' north of Lewis Avenue.

On the west side of 4th Street between 130' north of Lewis Avenue and Carson Avenue.

On the west side of 4th Street between Charleston Boulevard and 260' north of Charleston Boulevard.

On the west side of 4th Street between 510' north of Charleston Boulevard and Hoover Avenue.

On the east side of 4th Street between Charleston Boulevard and 140' north of Charleston Boulevard.

On the east side of 4th Street between 140' north of Charleston Boulevard and 220' north of Charleston Boulevard (Buses Excepted).

On the east side of 4th Street between 220' north of Charleston Boulevard and 300' north of Charleston Boulevard.

On the east side of 4th Street between 480' north of Charleston Boulevard and Hoover Avenue.

On the west side of 4th Street between Hoover Avenue and 240' north of Hoover Avenue.

On the west side of 4th Street between 380' north of Hoover Avenue and Gass Avenue.

On the east side of 4th Street between Hoover Avenue and 110' north of Hoover Avenue.

On the east side of 4th Street between 345' north of Hoover Avenue and Gass Avenue.

On the west side of 4th Street between Gass Avenue and 270' north of Gass Avenue.

On the west side of 4th Street between 385' north of Gass Avenue and Garces Avenue.

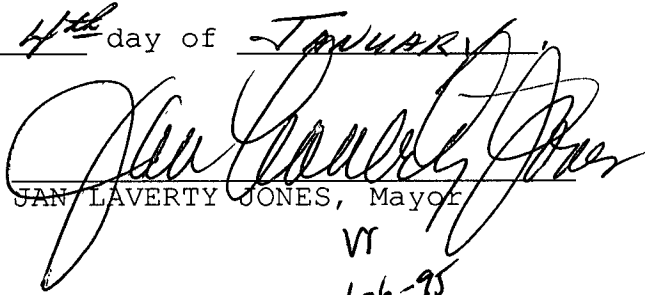
On the east side of 4th Street between Gass Avenue and 110' north of Gass Avenue.

On the east side of 4th Street between 110' north of Gass Avenue and 200' north of Gass Avenue (Buses Excepted).

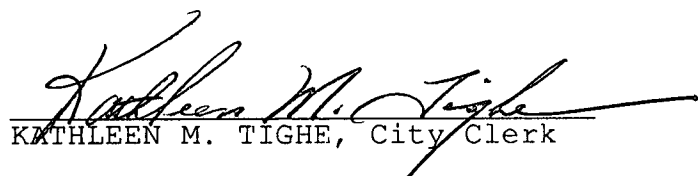
On the east side of 4th Street between 200' north of Gass Avenue and 320' north of Gass Avenue.
