

RESOLUTION NO. R-21-2000

RESOLUTION TO AUGMENT AND AMEND MULTIPURPOSE SPECIAL REVENUE FUNDS IN THE FISCAL YEAR 2000 BUDGET OF THE CITY OF LAS VEGAS

WHEREAS, the resources of the Multipurpose Special Revenue Fund are now determined to be \$15,893,373, as itemized in Exhibit A, which is attached hereto; and

WHEREAS, pursuant to NRS 354.615, the City of Las Vegas is desirous of augmenting and amending the Fiscal Year 2000 Budget for the purpose of effecting an increase in appropriations to recognize receipt of grant funding not identified in original budget of the Multipurpose Special Revenue Fund and an increase in Transfers In;

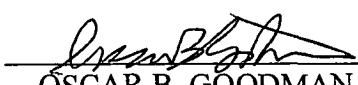
NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Las Vegas, Nevada, at a regular meeting thereof held on the 2nd day of February, 2000, that the Fiscal Year 2000 Budget for the Multipurpose Special Revenue Fund be increased from \$14,652,104 to \$15,893,373; and

BE IT FURTHER RESOLVED that expenditures totaling \$1,241,269, as itemized in Exhibit A, which is attached hereto, be approved and authorized; and

BE IT FURTHER RESOLVED that said augmentation and amendment as described above shall be effective upon delivery of a certified copy of the Resolution to the Nevada State Department of Taxation.

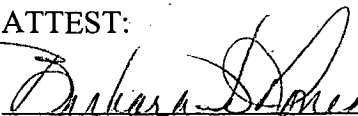
