

R E S O L U T I O N

**WHEREAS**, various sections of TITLE 11 of the Las Vegas Municipal Code allow for additions to and corrections of the schedules which are established in the respective sections to be effected by Resolution; and

**WHEREAS**, it has been determined and recommended by the Traffic and Parking Commission and the Traffic Engineer that the following additions and corrections be made in said schedules; and

**NOW, THEREFORE**, be it resolved by the City Council of the City of Las Vegas, Nevada, that the following schedules pertaining to TITLE 11 of the City Code be amended as follows:

**Schedule 14-I** be amended to include the following Through Streets:

Alexander Road from the west City limit to Rainbow Boulevard  
Antelope Way from Charleston Boulevard to Westcliff Drive  
Apple Drive at all points in the City  
Campbell Drive from Oakey Boulevard to Alta Drive  
Cimarron Road from Sahara Avenue to Westcliff Drive  
Cimarron Road from Washington Avenue to Vegas Drive  
Craig Road at all points in the City  
Desert Inn Road at all points in the City  
Gowan Road at all points in the City  
Grand Canyon Drive at all points in the City  
Hualapai Way at all points in the City  
Lake North Drive at all points in the City  
Lake East Drive at all points in the City  
Lake West Drive at all points in the City  
Lake South Drive at all points in the City  
Mariner Cove Drive at all points in the City  
Marion Drive from Stewart Avenue to Bonanza Road  
Peak Drive from Rainbow Boulevard to Jones Boulevard  
Rainbow Boulevard at all points in the City  
Red Hills Road at all points in the City  
Sirius Avenue from Arville Street to Valley View Boulevard  
Tenaya Way from Ann Road to the north City limit  
Tenaya Way from Vegas Drive to Lone Mountain Road

Westcliff Drive from Durango Drive to Rainbow Boulevard

Wilshire Street from Sahara Avenue to Oakey Boulevard

**Schedule 14-I** be amended to delete the following Through Streets:

Rainbow Boulevard from Sahara Avenue to Charleston Boulevard

Rainbow Boulevard from Charleston Boulevard to U.S. 95

Rainbow Boulevard from U.S. 95 to Lone Mountain Road

Torrey Pines Drive from Sahara Avenue to Charleston Boulevard

Torrey Pines Drive from Charleston Boulevard to Washington Avenue

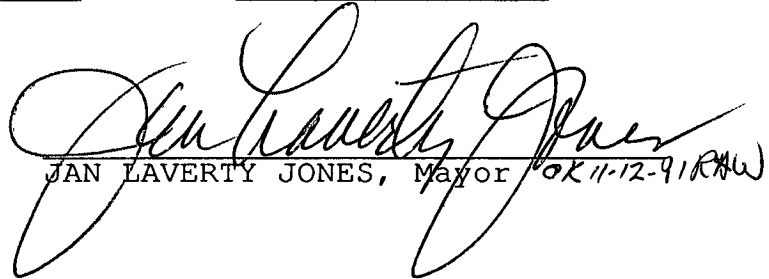
Torrey Pines Drive from Washington Avenue to the north City limits

**Schedule 17-VI** be amended to include the following Time Limited Parking Zone:

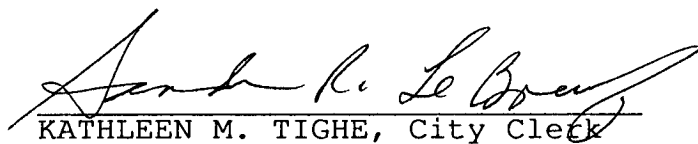
On the north side of Bonneville Avenue from First Street to the alley west of First Street (1 hour)

On the east side of Ninth Street from Gass Avenue to 267' north of Gass Avenue
