14 "Agreement"), which provides for the contribution of funds to "Owner" for making physical,
15 visual improvements to the building located on the Site, all as more fully set forth in the
16 Agreement.

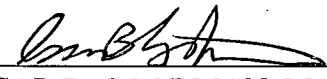

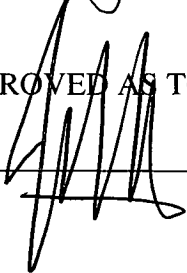

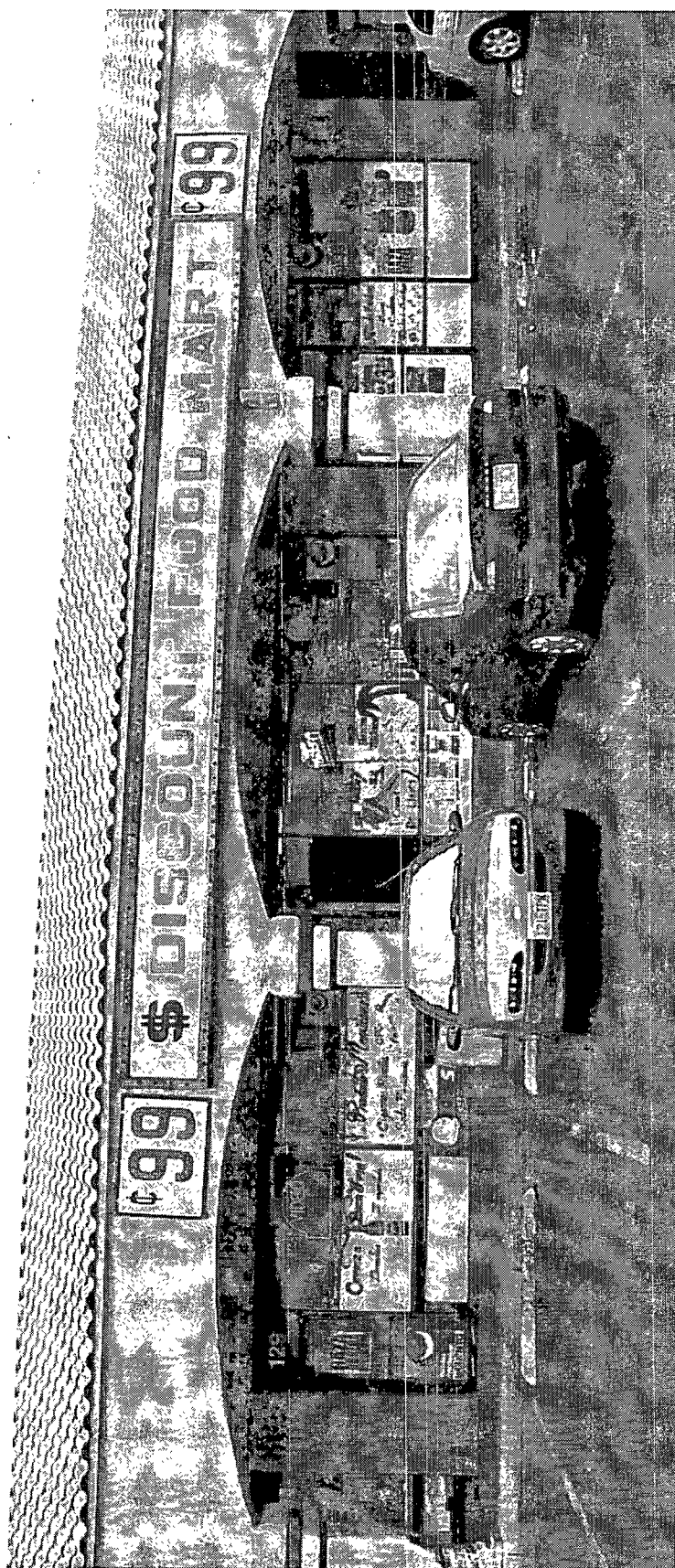
