

**RESOLUTION OF INTENT TO ANNEX TERRITORY GENERALLY LOCATED
WITHIN THE AREA BOUNDED BY WITCH MOUNTAIN ROAD ON THE WEST,
MOCCASIN ROAD ON THE NORTH, SHAUMBER ROAD ON THE EAST, AND IRON
MOUNTAIN ROAD ON THE SOUTH (ANX-23103)**

WHEREAS, the City Council of the City of Las Vegas, Nevada, deems it appropriate and in the best interests of the public health, safety, welfare, and convenience that certain territory be annexed to the City; and

WHEREAS, the territory in question is generally located within the area bounded by Witch Mountain Road on the west, Moccasin Road on the north, Shaumber Road on the east, and Iron Mountain Road on the south.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Las Vegas, Nevada, at a regular meeting thereof held on the 5th day of March, 2008, as follows:

1. It is the intention of the City Council to annex to the City the real property described as follows:

Those portions of the West Half (W 1/2) of Section 1 and those portions of Section 2, Township 19 South, Range 59 East, M.D.M., in County of Clark, State of Nevada, including the dedicated right-of-way and portions of KYLE CANYON ROAD (100 feet wide as measured from centerline thereof) as shown on the 2nd Amended Record of Survey in File 169, Page 61 of Clark County, Nevada Records, described as follows:

17 2. The City Council intends to meet on April 16, 2008, in the Council Chambers, City Hall, 400
18 Stewart Avenue, Las Vegas, Nevada, and, at or after the hour of 9:00 a.m. on that day, will conduct
19 a public hearing on the question of the annexation described in this Resolution.

20 3. The City Clerk is directed to give notice of the public hearing by:

21 (A) Publication thereof at least three (3) times in a newspaper published in the City of
22 Las Vegas and of general circulation in the area of the described territory. The first publication shall
23 be at least twenty (20) days prior to April 16, 2008, and not less than six (6) days shall intervene
24 between the first publication and the last publication; and

25 (B) Mailing notice thereof by certified mail, return receipt requested, to each record
26 owner of real property within the described territory, with the notice to be mailed at the time of the
27 first publication thereof. The notice shall be in substantially the same form as attached hereto as
28 Exhibit "A."

29 4. The Director of Public Works, and the Director of Planning and Development are directed
30 to prepare and submit to the City Council on March 19, 2008, a report setting forth plans for the
31 extension into the described territory of all major municipal services presently furnished by the City
32 to its residents and citizens. The report shall include without limitation:

33 (A) An accurate map or plat of the territory proposed to be annexed, prepared under the
34 supervision of a competent surveyor or engineer;

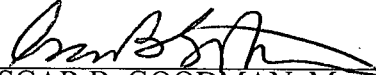

NOTICE OF HEARING ON QUESTION OF ANNEXATION OF TERRITORY (ANNEXATION ANX-23103)

NOTICE IS HEREBY GIVEN to the property owners within the area proposed to be annexed into the City of Las Vegas, Nevada, by Annexation ANX-23103 that:

1. The City Council of the City of Las Vegas, Nevada, has by Resolution duly passed, adopted and approved on the 5th day of March, 2008, declared its intention to annex to the City certain territory generally located within the area bounded by Witch Mountain Road on the west, Moccasin Road on the north, Shaumber Road on the east, and Iron Mountain Road on the south (ANX-23103).

The territory proposed to be annexed is more particularly described as follows:

Those portions of the West Half (W 1/2) of Section 1 and those portions of Section 2, Township 19 South, Range 59 East, M.D.M., in County of Clark, State of Nevada, including the dedicated right-of-way and portions of KYLE CANYON ROAD (100 feet wide as measured from centerline thereof) as shown on the 2nd Amended Record of Survey in File 169, Page 61 of Clark County, Nevada Records, described as follows:

2. At its meeting of Wednesday, April 16, 2008, during the morning session commencing at the hour of 9:00 a.m. in the Council Chambers, City Hall, 400 Stewart Avenue, Las Vegas, Nevada, the City Council will conduct a public hearing on the question of the annexation described in this Notice.

3. A report setting forth the City's plans for the extension into the above-described territory of all major municipal services presently furnished by the City to its residents and citizens will be available for examination by the public in the Office of the City Clerk, City Hall, 400 Stewart Avenue, Las Vegas, Nevada, no later than twenty (20) days prior to the date of the public hearing. The report shall include:

- A. An accurate map or plat of the territory proposed to be annexed, prepared under the supervision of a competent surveyor or engineer;
- B. A map or maps of the City and the adjacent territory to show the following information:
 - (1) The present and proposed boundaries of the City;
 - (2) The present streets and sewer interceptors and outfalls;
 - (3) The proposed extension of the present streets and sewer interceptors and outfalls; and
 - (4) The present and proposed general land use pattern into the territory proposed to be annexed.

- C. A statement showing that the territory proposed to be annexed is eligible for annexation under NRS 268.570 to 268.608, inclusive.
4. The names and addresses of all record owners of real property within the above-described territory proposed to be annexed are as follows:

5. Any record owner of real property within the above-described territory may:
- A. Appear and be heard either in favor of or in protest of the proposed annexation at the public hearing;
 - B. File with the City Clerk a written protest of such annexation at any time within fifteen (15) days after the conclusion of the public hearing; or
 - C. Do both.

Unless a majority of the property owners in the territory proposed to be annexed protest the annexation either orally at the public hearing or in writing within fifteen (15) days after the conclusion of such public hearing, the City Council shall have authority to adopt an ordinance extending the corporate limits of the City of Las Vegas to include all or any part of the territory described in this Notice.
