A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAS VEGAS, NEVADA, TO ESTABLISH A COMMUNITY PARTICIPATION PROCESS FOR THE ELEVENTH YEAR COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, the City of Las Vegas intends to submit an Eleventh Year application for Community Development Block Grant funds under Title I of the Housing and Community Development Act of 1974 (P.L. 93-383) as amended; and

WHEREAS, the City of Las Vegas desires to insure that its residents are afforded complete information on funding available, eligible activities, and possible program directions; and

WHEREAS, the City of Las Vegas desires to insure the adequate representation of community organizations, groups and individuals in the application development process; and

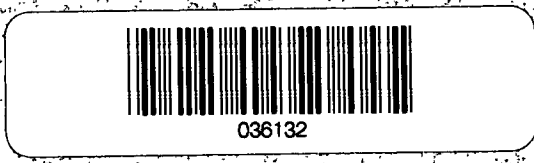
WHEREAS, the Citizens Advisory Review Board serves to facilitate the citizen participation process by providing for the identification of community needs in the area of community development; and

WHEREAS, the City of Las Vegas recognizes that citizen input is necessary to the development of the application and determination of program priorities; and

WHEREAS, the City of Las Vegas desires that citizens have an opportunity to participate in the development of the Final Statement prior to its submission to the Department of Housing and Urban Development (HUD).

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Las Vegas:

1. That a Community Participation Process be developed for the Eleventh Year Community Development Block Grant Program.
2. That the Department of Economic and Urban Development shall be responsible for the development, publication and administration of the Citizens Participation Process.
3. That notice of such Citizen Participation Process shall be published.



1           4. That said notice shall include a time table and shall provide  
2 a brief description of the purpose of each public meeting and hearing.

3           5. That the Citizen Participation Process shall commence in  
4 January, 1985 and shall continue until the submission of the Eleventh Year  
5 Community Development Block Grant application to the Department of Housing  
6 and Urban Development.


7           6. Commencing with the adoption of this Resolution, participation  
8 in the Community Participation Process referred to above shall be open to  
9 the general public and to any individual or representative of any groups or  
10 organizations in the City of Las Vegas desiring to be part of said Process.

11           7. The Citizens Advisory Review Board shall continue in operation  
12 as constituted with vacancies to be filled by appointment of the Mayor.


13           8. A publicity campaign shall be initiated including new adver-  
14 tisements and television and radio public service announcements to inform  
15 citizens of the public meetings and public hearings.

16           9. The Department of Economic and Urban Development shall provide  
17 staff resources throughout this process for the purpose of providing all  
18 relevant information on the Community Development application process.
