A RESOLUTION BY THE CITY COUNCIL
OF THE CITY OF LAS VEGAS, NEVADA
SUPPORTING THE DEVELOPMENT AND REVITALIZATION
OF THE SPECIAL IMPACT AREA DESIGNATED FOR
CENSUS TRACTS 35, 3.01, 3.02 and 2.01

WHEREAS, the City of Las Vegas recognizes the ongoing need for neighborhood and commercial revitalization for Las Vegas; and

WHEREAS, the City of Las Vegas, through the Community Development Program and other projects and programs, is addressing the needs of neighborhood and commercial revitalization; and

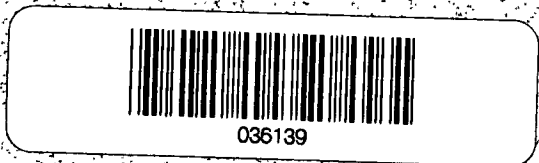
WHEREAS, the City of Las Vegas desires to expand and broaden the activity and programs designed to provide for neighborhood and commercial revitalization; and

WHEREAS, the City of Las Vegas further desires to encourage, support and cooperate with agencies, organizations and groups working to revitalize neighborhood and commercial areas within the City; and

WHEREAS, the City of Las Vegas desires to see that funds from all possible state and federal assistance programs are available for neighborhood and commercial revitalization programs; and

WHEREAS, the Nevada Black Chamber of Commerce, Economic Development Administration is currently in the process of developing a planning and needs assessment base for the development of an overall economic development plan; and

WHEREAS, Part of said activities by the Nevada Black Chamber of Commerce and the Economic Development Administration include the development and revitalization of the special impact area as designated for Census Tracts 35, 3.01, 3.02 and 2.01; and



1 WHEREAS, the City of Las Vegas desires that these
2 Census Tracts within the City retain the designation as a
3 special impact area so that federal funds can be sought from
4 such agencies as the Economic Development Administration, and
5 such other federal agencies as may be appropriate.

6 NOW, THEREFORE, BE IT RESOLVED, by the City Council
7 of the City of Las Vegas:

8 1. That the City of Las Vegas hereby acknowledges
9 and supports the retention of the designation of Census Tracts
10 35, 3.01, 3.02 and 2.01 as a special impact area.

11 2. That the City of Las Vegas supports the development
12 of an Overall Economic Development Plan for any area funded
13 from the sources described above.

14 3. That the Department of Economic and Urban
15 Development is hereby authorized to be the City's agent for
16 working with the Nevada Black Chamber of Commerce, Economic
17 Development Administration, and other community and govern-
18 mental organizations and agencies in developing an overall
19 economic development plan and revitalizing the special impact
20 area.

21 4. That the Department of Economic and Urban
22 Development hereby authorized to provide such documentation,
23 forms and materials as may be required to develop the overall
24 economic development plan for the special impact area's
25 revitalization.

26 5. That the Mayor is hereby authorized to execute
27 such assurances or other documents as may be necessary for
28 the retention of the special impact area designation and the
29 overall economic development plan and the City Clerk is hereby
30 authorized to attest the same.
