A RESOLUTION BY THE CITY COUNCIL
OF THE CITY OF LAS VEGAS, NEVADA
SUPPORTING PHASE II OF THE OVERALL
ECONOMIC DEVELOPMENT PLAN OF THE
SPECIAL IMPACT AREA DESIGNATED FOR
CENSUS TRACTS 35, 3.01, 3.02 and 2.01

WHEREAS, the City of Las Vegas recognizes the ongoing need for
economic development for the Special Impact Area; and

WHEREAS, the City of Las Vegas, through the Community Development
Program and other projects and programs, is addressing the needs of econo-
mic development; and

WHEREAS, the City of Las Vegas desires to expand and broaden the
activity and programs designed to provide for economic development; and

WHEREAS, the City of Las Vegas further desires to encourage, sup-
port and cooperate with agencies, organizations and groups working for the
economic development within the City; and

WHEREAS, the City of Las Vegas desires to see that funds from all
possible state and federal assistance programs are available for economic
development; and

WHEREAS, the Nevada Black Chamber of Commerce and Economic
Development Administration have established an approved Overall Economic
Development Plan for the Special Impact Area which includes the City's
Census Tracts 35, 3.01, 3.02 and 2.01; and

WHEREAS, the City of Las Vegas desires that these Census Tracts
within the City retain the designation as a Special Impact Area so that
federal funds can be sought from such agencies as the Economic Development
Administration, and such other federal agencies as may be appropriate.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of
Las Vegas:

1. That the City of Las Vegas hereby acknowledges and supports
the retention of the designation of Census Tracts 35, 3.01, 3.02 and 2.01
as a Special Impact Area for the Overall Economic Development Plan (OEDP).

2. That the City of Las Vegas supports the efforts of the Nevada
Black Chamber of Commerce as the planning arm for Phase II of the Overall

1 Economic Development Plan (OEDP).

2 3. That the Department of Economic and Urban Development is
3 hereby authorized to be the City's agent for working with the Nevada Black
4 Chamber of Commerce, Economic Development Administration (EDA) and other
5 community and governmental organizations and agencies in developing Phase
6 II of the Overall Economic Development Plan (OEDP) and revitalizing the
7 Special Impact Area (SIA).

8 4. That the Department of Economic and Urban Development hereby
9 be authorized to provide such documentation, forms and materials as may be
10 required to develop Phase II of the Overall Economic Development Plan for
11 the Special Impact Area's revitalization.

12 5. That the City of Las Vegas support the Rowe, Inc., project as
13 the priority project to Economic Development Administration funds as an
14 Overall Economic Development Plan project.

15 6. That the City shall support the Nevada Black Chamber of
16 Commerce in its efforts to provide the local match needed for EDA's Phase
17 II planning grant.

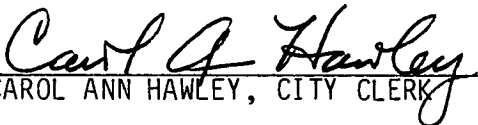
18 7. That the Mayor is hereby authorized to execute such assuran-

21 City Clerk is hereby authorized to attest the same.

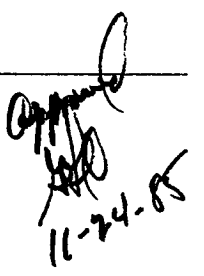
