

1 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAS VEGAS,
2 NEVADA, AUTHORIZING THE FILING OF AN APPLICATION WITH THE
3 DEPARTMENT OF TRANSPORTATION, UNITED STATES OF AMERICA,
4 FOR A GRANT UNDER THE URBAN MASS TRANSPORTATION ACT OF
5 1964, AS AMENDED, FOR INTERIOR FURNISHINGS IN THE DOWNTOWN
6 TRANSPORTATION CENTER

7 WHEREAS, the Secretary of Transportation is authorized to make grants
8 for mass transportation projects; and

9 WHEREAS, the contract for financial assistance will impose certain
10 obligations upon the applicant, including the provision by it of the local
11 share of project costs; and

12 WHEREAS, it is required by the United States Department of Transpor-
13 tation in accord with the provisions of Title VI of the Civil Rights Act of
14 1964, that in connection with the filing of an application for assistance
15 under the Urban Mass Transportation Act of 1964, as amended, the applicant
16 give an assurance that it will comply with Title VI of the Civil Rights Act of
17 1964 and the United States Department of Transportation requirements there-
18 under; and

19 WHEREAS, it is the goal of the applicant that minority and disadvan-
20 tagged business enterprise be utilized to the fullest extent possible in con-
21 nection with this project, and that definite procedures shall be established
22 and administered to insure that minority and disadvantaged businesses shall
23 have the maximum feasible opportunity to compete for contracts when procuring
24 construction contracts, supplies, equipment contracts, or consultant and
25 other services;

26 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Las
27 Vegas, Nevada:

28 1. That the Mayor of the City of Las Vegas, Nevada, is authorized to
29 execute and file an application on behalf of the City of Las Vegas with the
30 United States Department of Transportation, to aid in the financing of Inter-
31 ior Furnishings in the Downtown Transportation Center, pursuant to Section 9
32 of the Urban Mass Transportation Act of 1964, as amended.

2. That the Mayor of the City of Las Vegas, Nevada, is authorized to

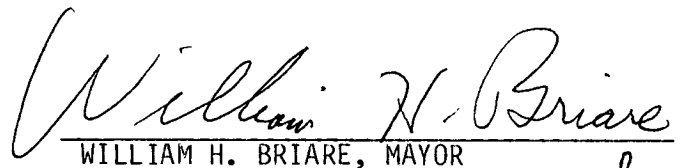


1 execute and file with such application an assurance or any other document re-
2 quired by the United States Department of Transportation effectuating the pur-
3 poses of Title VI of the Civil Rights Act of 1964.

4 3. That the City Manager of the City of Las Vegas, working in coor-
5 dination with the Director of the Regional Transportation Commission, is here-
6 by designated as agent to act on behalf of the Mayor of the City of Las Vegas
7 in furnishing such additional information as the United States Department of
8 Transportation may require in connection with the application of the project.

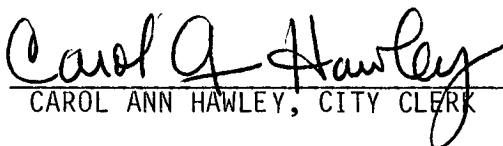
9 4. That the City Manager of the City of Las Vegas, working in coor-
10 dination with the Director of the Regional Transportation Commission is hereby
11 designated as an agent on behalf of the Mayor of the City of Las Vegas and is
12 authorized to set forth and execute affirmative minority and disadvantaged
13 business policies in connection with the project's procurement needs.
