

R E S O L U T I O N

WHEREAS, various sections of TITLE 11 of the Las Vegas Municipal Code allow for additions to and corrections of the schedules which are established in the respective sections to be effected by Resolution; and

WHEREAS, it has been determined by the City Council and the Traffic Engineer that, due to the changes in bus routes and the bus stops, the following additions and corrections be made in said schedules; and

NOW, THEREFORE, be it resolved by the City Council of the City of Las Vegas, Nevada, that the following schedules pertaining to TITLE 11 of the City Code be amended as follows:

Schedule 3-I be amended to include the following Parking Meter Zones:

On the east side of Fourth Street from 110' north of Carson Avenue to Fremont Street.

On the east side of Fourth Street from 70' north of Ogden Avenue to Stewart Avenue.

On the east side of Seventh Street from Carson Avenue to 140' south of Fremont Street.

On the south side of Bridger Avenue from First Street to 75' west of Casino Center Boulevard.

On the south side of Bridger Avenue from 70' east of Third Street to Las Vegas Boulevard.

On the north side of Carson Avenue from Third Street to Fourth Street.

On the north side of Carson Avenue from 95' east of Fourth Street to 75' east of Las Vegas Boulevard.



Schedule 3-I be amended to delete the following
Parking Meter Zones:

On the east side of Fourth Street from Carson Avenue to
Fremont Street.

On the east side of Fourth Street from 70' north of Ogden
Avenue to 170' north of Ogden Avenue.

On the east side of Fourth Street from 270' north of Ogden
Avenue to Stewart Avenue.

On the east side of Seventh Street from Carson Avenue to
Fremont Street.

On the south side of Bridger Avenue from First Street to
Casino Center Avenue.

On the south side of Bridger Avenue from Third Street to
Las Vegas Boulevard.

On the north side of Carson Avenue from Third Street to
75' east of Las Vegas Boulevard.

Schedule 17-III be amended to include the following No
Parking Anytime Zones:

On the west side of Third Street from Carson Avenue to 80'
north, buses excepted.

On the east side of Fourth Street from Carson Avenue to
65' north.

On the east side of Fourth Street from 65' north of Carson
Avenue to 110' north of Carson Avenue, buses excepted.

On the east side of Seventh Street from 140' south of
Fremont Street to Fremont Street, buses excepted.

On the south side of Bridger Avenue from 75' west of Casino Center Boulevard to Casino Center Boulevard, buses excepted.

On the south side of Bridger Avenue from Third Street to 70' east, buses excepted.

On the south side of Bridger Avenue from 60' west of Sixth Street to Sixth Street, buses excepted.

On the north side of Carson Avenue from Fourth Street to 95' east, buses excepted.

Schedule 17-III be amended to delete the following No Parking Anytime Zone:

On the east side of Fourth Street from 170' north of Ogden Avenue to 270' north of Ogden Avenue.

Schedule 17-VI be amended to include the following Time Limited Parking Zone:

On the south side of Bridger Avenue from 46' east of Alley to 60' west of Sixth Street.

Schedule 17-VI be amended to delete the following Time Limited Parking Zone:

On the south side of Bridger Avenue from 46' east of Alley to Sixth Street.

Schedule 18-VI be amended to include the following Thirty Minute Tour Bus Parking Zone:

On the west side of Third Street from 80' north of Carson Avenue to Fremont Street.

Schedule 18-VI be amended to delete the following
Thirty Minute Tour Bus Parking Zone:

On the west side of Third Street from 60' north of Carson
Avenue to Fremont Street.
