PARTICIPATION PLAN AND PROCESS FOR THE SIXTEENTH
YEAR COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

WHEREAS, the City of Las Vegas intends to submit an application for Sixteenth Year Community Development Block Grant funds under Title I of the Housing and Community Development Act of 1974 (P.L. 93-383) as amended; and

WHEREAS, said City desires to insure that its residents are afforded complete information on funding available, eligible activities, and possible program directions; and

WHEREAS, said City desires to insure adequate representation of community organizations, groups and individuals in the public services application development process; and

WHEREAS, the Department of Economic and Urban Development of said City provides information to citizens on the Community Development Block Grant Program, the meetings and functions of the citizen participation process, and the application process; and

WHEREAS, said City recognizes that citizen input is necessary for the development of the application process and the determination of program priorities; and

WHEREAS, said City and Clark County may desire to undertake certain community development improvements within the city limits of said City in the furtherance of the Community Development Block Grant funding activities; and

WHEREAS, said City desires that citizens have an opportunity to participate in the development of the Final Statement prior to its submission to the Department of Housing and Urban Development (HUD).

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Las Vegas:

1. That a community participation plan and process be developed for the Sixteenth Year Community Development Block Grant Program.

2. That the Department of Economic and Urban Development of said City shall be responsible for the development, publication and administration of the citizens participation plan and process.

3. That the citizen participation process shall include at least one public meeting or hearing as required by HUD regulations.



1 4. That the Citizen Participation Plan shall include a time table
2 and shall provide a brief description of the purpose of each public
3 meeting or hearing.

4 5. That the citizen participation process shall commence in
5 November, 1989, and shall continue until the submission of the Sixteenth Year
6 Community Development Block Grant application to the Department of Housing and
7 Urban Development.

8 6. That, commencing with the adoption of this Resolution,
9 participation in the community participation process shall be opened to the
10 general public and to any individual or representative of any group or
11 organization within said City that desires to be part of said process.

12 7. An informational campaign shall be initiated by the said
13 Department of Economic and Urban Development that shall include public service
14 announcements to inform citizens of the aforementioned process.

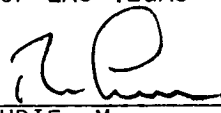
15 8. Said Department of Economic and Urban Development will provide
16 staff resources throughout this process for the purpose of providing all
17 relevant information on the Community Development Block Grant application
18 process.

19 9. That said City and Clark County, in the pursuance of their
20 respective Community Development Block Grant activities, may undertake joint
21 funded projects.

22 10. That the funding of the City of Las Vegas Housing Rehabilitation
23 Assistance Program be recapitalized at no less than Three Hundred Fifty
24 Thousand (\$350,000) Dollars.
