**RESOLUTION IN SUPPORT OF A JOINT PROPOSAL BY THE CITY OF LAS VEGAS
AND THE CITY OF NORTH LAS VEGAS TO HOST THE 2013 CONFERENCE OF
THE NEVADA LEAGUE OF CITIES AND MUNICIPALITIES**

WHEREAS, the Nevada League of Cities & Municipalities (the "NLCM") has 24 member municipalities that include all Nevada's incorporated cities, as well as some unincorporated towns and general improvement districts; and

WHEREAS, the membership represents very diverse communities around the State, from the City of Wells, to Incline Village, to Boulder City, to the largest city—the City of Las Vegas; and

WHEREAS, the purposes of the NLCM include:

–To foster periodic conferences or meetings of member municipal officials for the discussion of municipal problems and for the purpose of promoting governmental efficiency;

–To disseminate knowledge relating to municipal government by all appropriate means and to arouse greater interest and more active civic consciousness among the people as to its importance and significance; and

–To promote good legislation respecting municipal affairs and to oppose such measures as seem to be against public interest; and

WHEREAS, the NLCM hosts one major annual conference each year, bringing together Nevada's local elected officials and key administrative staff in an educational environment with topics covering current and emerging issues and technologies; and

WHEREAS, the annual conference provides a wide variety of educational and training opportunities for municipal officials and carries out organizational business for the discussion of municipal problems; and

WHEREAS, each annual conference is to be at a place designated by the League membership at a previous annual conference; and

WHEREAS, the NLCM will hold its 52nd Annual Conference in Mesquite, Nevada, on October 5-7, 2011; and

WHEREAS, at the conference the NLCM will consider proposals for the location of its 2013 Annual Conference; and

1 WHEREAS, in the spirit of intergovernmental cooperation and taking into account
2 the current fiscal conditions of both cities, it has been proposed that the two cities submit a joint
3 proposal to host the NLCM's Annual Conference for 2013.

4 NOW, THEREFORE, LET BE IT RESOLVED by the City Council of the City of
5 Las Vegas to submit to the 2011 NLCM Site Selection Committee, together with the City of North
6 Las Vegas, a joint proposal to host the NLCM's 2013 Annual Conference.

7 PASSED, ADOPTED, AND APPROVED this 5th day of OCTOBER, 2011.

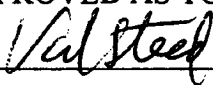
