RESOLUTION CONSENTING TO CERTAIN UNDERTAKINGS OF THE CITY OF LAS VEGAS REDEVELOPMENT AGENCY IN CONNECTION WITH THE COMMERCIAL VIP AGREEMENT ("CVIP") BETWEEN THE CITY OF LAS VEGAS REDEVELOPMENT AGENCY ("AGENCY") AND ALLO, LLC ("PARTICIPANT") FOR THE PROJECT CONCERNING THE DEVELOPMENT OF IMPROVEMENTS TO REAL PROPERTY DESCRIBED AS APN 162-03-110-078

WHEREAS, the City of Las Vegas Redevelopment Agency (the "Agency") adopted on March 5, 1986, that plan of redevelopment entitled, to-wit: the Redevelopment Plan for the Downtown Las Vegas Redevelopment Area pursuant to Ordinance 3218, which Redevelopment Plan has been subsequently amended on February 3, 1988, by Ordinance 3339; April 11, 1992, by Ordinance 3637, on November 4, 1996, by Ordinance 4036, on December 17, 2003, by Ordinance 5652 and on May 17, 2006, by Ordinance 5830 (the "Redevelopment Plan"); and

WHEREAS, the Redevelopment Plan identifies and designates an area within the corporate boundaries of the City of Las Vegas (the "Redevelopment Area") as in need of redevelopment in order to eliminate the environmental deficiencies and blight existing therein; and

WHEREAS, the Agency approved on October 20, 2004 the form for the Commercial VIP Agreement, the Commercial VIP Affidavit, and the Commercial VIP Program Manual, in order to provide funding to owners of commercial properties located within the Redevelopment Area for the purpose of making improvements to the exterior of such commercial properties and/or for the development of a vacant parcel with a new commercial building; and;

1 WHEREAS, ALLO, LLC (the "PARTICIPANT") is the owner of real property
2 and improvements located at 1119 MAIN STREET, and which parcel is commonly known as
3 APN 162-03-110-078 (the "Site"); and

4 WHEREAS, ALLO, LLC (the "PARTICIPANT") is the owner of the real
5 property located at 1119 MAIN STREET and is undertaking certain exterior improvements to
6 the property or the redevelopment of an underdeveloped property in accordance with the
7 Commercial VIP Program;

9 WHEREAS, the City Council of the City of Las Vegas has considered the
10 findings that the development of improvements to a building, facilities, structures or other
11 improvements to be located at the Site are of benefit to the Redevelopment Area or the
12 immediate neighborhood in which the Redevelopment Area is located; and

14 WHEREAS, the City Council of the City of Las Vegas has considered the
15 findings that no other reasonable means of financing the building, facilities or structures or
16 other improvements on the Site are available; and

18 WHEREAS, the City Council of the City of Las Vegas has considered the
19 undertakings of the Agency in connection with the Commercial VIP Agreement (the
20 "Agreement" and attached hereto as Exhibit A), which provides for the contribution of funds to
21 ALLO, LLC for making physical, visual improvements to the building or property located on
22 the Site, all as more fully set forth in the Agreement.

24 NOW, THEREFORE, BE IT HEREBY RESOLVED that the City Council of
25 the City of Las Vegas hereby finds and determines that the development of building, facilities,
26 structures or other improvements on the Site are of benefit to the Redevelopment Area or the
27 immediate neighborhood in which the Redevelopment Area is located; and

1 RESOLVED FURTHER, that the City Council of the City of Las Vegas hereby
2 finds and determines there are no reasonable means of financing those building, facilities,
3 structural or other improvements on the Site; and

4 RESOLVED FURTHER, that the City Council of the City of Las Vegas hereby
5 consents to the undertakings of the Agency in connection with the Agreement with the
6 "Participant" for the Project concerning the development on the Site.

8 THE FOREGOING RESOLUTION was passed, adopted and approved this
