

RESOLUTION CHANGING HYDE PARK TO CRAGIN PARK

1 WHEREAS, the Honorable E. W. Cragin has served as Mayor
2 of the City of Las Vegas for many years during which he developed
3 and administered a sound municipal administration which resulted
4 in continuous development, growth and improvement for the City of
5 Las Vegas; and

6 WHEREAS, the said E. W. Cragin was always ready, willing
7 and able to give, without reservation, of his many qualities of
8 leadership and to guide and direct those who foresaw an ever
9 expanding future for the City of Las Vegas; and

10 WHEREAS, during all of his many years of residence in the
11 City of Las Vegas, the said Honorable E. W. Cragin was faithful
12 and devoted to the betterment of his community, and environment,
13 whether as a public official or as a responsible leader of the
14 many charitable and service organizations of which he was a member;

16 WHEREAS, the general welfare of the City of Las Vegas, the
17 County of Clark and the State of Nevada has been benefitted and
18 improved by the innumerable improvements of the said E. W. Cragin
19 throughout a lifetime of vigorous, enthusiastic and unselfish
20 activity in behalf of his fellowman; and

21 WHEREAS, the Board of Commissioners of the City of Las
22 Vegas deeply and sincerely regrets the unfortunate and untimely
23 passing of the said E. W. Cragin and deems it advisable and
24 desirable to commemorate his many years of devotion to the public
25 interests by perpetuating his name in a manner that will at all
26 times remind the citizens of Las Vegas of his service and achieve-
27 ments,

28 NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners
29 of the City of Las Vegas, at a regular meeting held on the 15th
30 day of July, 1959, that that certain park in the Hyde Park Sub-
31 division heretofore known and designated as "Hyde Park" shall
32 be, from and after the 15th day of July, 1959 named, known and



1 designated as "CRAGIN PARK" in honor of the said E. W. CRAGIN,
2 and that all maps of the City of Las Vegas shall be officially
3 changed to show the aforesaid designation of "CRAGIN PARK".

4 BE IT FURTHER RESOLVED that this Resolution be entered in
5 the official records of the City of Las Vegas; and

6 BE IT FURTHER RESOLVED that a certified copy of this
7 Resolution be transmitted to the beloved wife of the late
8 E. W. CRAGIN, together with the sincere sympathy of the City of
9 Las Vegas in the memory of a beloved public servant.
