RESOLUTION NO. R-13-2015

**RESOLUTION SUPPORTING SENATE BILL 190 OF THE 2015 SESSION OF THE NEVADA
LEGISLATURE PERTAINING TO EMPLOYMENT**

WHEREAS, Senate Bill 190 (SB 190) of the 2015 Legislative Session pertains to employment; and

WHEREAS, the title of SB 190 reads as follows:

AN ACT relating to employment; making it an unlawful employment practice for an employer, employment agency or labor organization to discriminate against a person for inquiring about, discussing or disclosing information about wages in certain circumstances; revising provisions relating to unlawful employment practices; revising provisions governing the filing of complaints of employment discrimination with the Nevada Equal Rights Commission; revising the relief that the Commission may order if it determines that an unlawful employment practice has occurred; revising provisions relating to the time in which an employee may seek relief in district court for a claim of unlawful employment practices; and providing other matters properly relating thereto;

and

WHEREAS, among other things, the bill would make it an unlawful employment practice for an employer, employment agency, labor organization or joint labor-management committee to use a qualification which is based upon or derived from a difference on the basis of sex or a qualification that an employer, employment agency, labor organization or joint labor-management committee has refused to change after being presented by an affected person with an alternative practice that would serve the same purpose in a manner that is less discriminatory on the basis of sex; and

WHEREAS, as an employer, the City makes every effort to comply with applicable statutes and regulations pertaining to employment matters; and

WHEREAS, it is believed that the City, through the City's purchasing and contracting function, requires its contractors to comply with applicable statutes and regulations pertaining to employment matters; and

WHEREAS, it has been proposed that the City Council of the City Las Vegas support the Nevada Legislature's adoption of SB190.

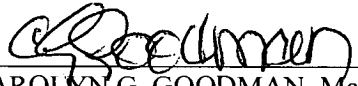

AN ACT relating to employment; making it an unlawful employment practice for an employer, employment agency or labor organization to discriminate against a person for inquiring about, discussing or disclosing information about wages in certain circumstances; revising provisions relating to unlawful employment practices; revising provisions governing the filing of complaints of employment discrimination with the Nevada Equal Rights Commission; revising the relief that the Commission may order if it determines that an unlawful employment practice has occurred; revising provisions relating to the time in which an employee may seek relief in district court for a claim of unlawful employment practices; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law prohibits an employer, employment agency, labor organization or joint labor-management committee from discriminating against any person with respect to employment or membership, as applicable, on the basis of race, color, religion, sex, sexual orientation, gender identity or expression, age, disability or national origin. (NRS 613.330) Existing law also requires the Nevada Equal Rights Commission to accept certain complaints alleging unlawful discriminatory practices and, if the Commission determines that an unlawful practice has occurred, order: (1) the person engaging in the practice to cease and desist; and (2) for a case involving an unlawful employment practice, the restoration of all benefits and rights to which the aggrieved person is entitled. (NRS 233.157, 233.160, 233.170)

Section 1 of this bill revises provisions governing the filing of complaints alleging a practice of unlawful discrimination in compensation to require that the complaint be filed within 300 days after any date on which: (1) a decision or practice resulting in discriminatory compensation is adopted; (2) a person becomes subject to such a decision or practice; or (3) a person is affected by an application of such a decision or practice. **Section 1** also requires the Commission to notify each party to a complaint of the period of time that a person may apply to a district court for relief. **Section 2** of this bill revises the powers of the Commission to order remedies for unlawful employment practices. **Section 2** authorizes the Commission to: (1) award back pay for a period beginning 2 years before the date of the filing of a complaint regarding an unlawful employment practice and ending on the date the Commission issues an order regarding the complaint; (2) award costs and reasonable attorney's fees in cases involving an unlawful employment practice; (3) order payment of compensatory damages or, if the employer acted with malice or reckless indifference, punitive damages in cases involving an unlawful employment practice relating to discrimination on the basis of sex; and (4) order a civil penalty, in increasing amounts, for an unlawful employment practice that it determines is willful based on the number of such practices the person has committed in the previous 5 years.

Section 12 of this bill requires the Commission, if it does not conclude that an unfair employment practice has occurred, to issue a letter to the person who filed the complaint concerning an unfair employment practice. This letter must notify the person of his or her right to apply to the district court for an order relating to the alleged unfair employment practice. **Section 13** of this bill provides that a person may apply to a district court for relief pursuant to **section 12** up to 180 days after the date of issuance of the letter described in **section 12**, in addition to the existing authority to apply to a district court for relief up to 180 days after the date of the alleged act.

This bill also enacts several provisions contained in the federal Paycheck Fairness Act, which was introduced in the United States Senate on January 23, 2013, but has not been enacted to date. (S. 84 (113th)) Specifically, **section 3** of this bill prohibits an employer, employment agency or labor organization from discriminating against any person with respect to employment or membership, as applicable, for inquiring about, discussing or disclosing information about wages unless the person has access to information about the wages of other persons as part of his or her essential job functions and discloses the information to a person who does not have access to that information. **Section 7** of this bill provides that it is an unlawful employment practice to use a qualification which is based upon or derived from a difference on the basis of sex or a qualification that an employer, employment agency, labor organization or joint labor-management committee has refused to change after being presented by an affected person with an alternative practice that would serve the same purpose in a manner that is less discriminatory on the basis of sex.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 233.160 is hereby amended to read as follows:
2 233.160 1. A complaint which alleges unlawful
3 discriminatory practices in:

4 (a) Housing must be filed with the Commission not later than 1
5 year after the date of the occurrence of the alleged practice or the
6 date on which the practice terminated.

7 (b) Employment or public accommodations must be filed with
8 the Commission not later than 300 days after the date of the
9 occurrence of the alleged practice.

10 A complaint is timely if it is filed with an appropriate federal
11 agency within that period. A complainant shall not file a complaint
12 with the Commission if any other state or federal administrative
13 body or officer which has comparable jurisdiction to adjudicate
14 complaints of discriminatory practices has made a decision upon a
15 complaint based upon the same facts and legal theory.

16 2. The complainant shall specify in the complaint the alleged
17 unlawful practice and sign it under oath.

18 3. The Commission shall send to the party against whom an
19 unlawful discriminatory practice is alleged:

20 (a) A copy of the complaint;

21 (b) An explanation of the rights which are available to that
22 party; and

23 (c) A copy of the Commission's procedures.

24 **4. The Commission shall notify each party to the complaint of**
25 **the limitation on the period of time that a person may apply to the**
26 **district court for relief pursuant to NRS 613.430.**

27 **5. For the purposes of paragraph (b) of subsection 1, an**
28 **unlawful discriminatory practice in employment which relates to**
29 **compensation occurs on each date on which:**

30 **(a) A decision or other practice resulting in discriminatory**
31 **compensation is adopted;**

32 **(b) A person becomes subject to a decision or other practice**
33 **resulting in discriminatory compensation; or**

34 **(c) A person is affected by an application of a decision or other**
35 **practice resulting in discriminatory compensation, including,**
36 **without limitation, each payment of wages, benefits or other**
37 **compensation that is affected by the decision or other practice.**

38 **Sec. 2.** NRS 233.170 is hereby amended to read as follows:

39 233.170 1. When a complaint is filed whose allegations if
40 true would support a finding of unlawful practice, the Commission
41 shall determine whether to hold an informal meeting to attempt a
42 settlement of the dispute in accordance with the regulations adopted

1 pursuant to NRS 233.157. If the Commission determines to hold an
2 informal meeting, the Administrator may, to prepare for the
3 meeting, request from each party any information which is
4 reasonably relevant to the complaint. No further action may be taken
5 if the parties agree to a settlement.

6 2. If an agreement is not reached at the informal meeting, the
7 Administrator shall determine whether to conduct an investigation
8 into the alleged unlawful practice in accordance with the regulations
9 adopted pursuant to NRS 233.157. After the investigation, if the
10 Administrator determines that an unlawful practice has occurred,
11 the Administrator shall attempt to mediate between or reconcile the
12 parties. The party against whom a complaint was filed may agree to
13 cease the unlawful practice. If an agreement is reached, no further
14 action may be taken by the complainant or by the Commission.

15 3. If the attempts at mediation or conciliation fail, the
16 Commission may hold a public hearing on the matter. After the
17 hearing, if the Commission determines that an unlawful practice has
18 occurred, it may:

19 (a) Serve a copy of its findings of fact within 10 calendar days
20 upon any person found to have engaged in the unlawful practice;
21 and

22 (b) Order the person to:

23 (1) Cease and desist from the unlawful practice.

24 (2) In cases involving an unlawful employment practice,
25 restore all benefits and rights to which the aggrieved person is
26 entitled, including, but not limited to, rehiring, back pay for a period
27 ~~[not to exceed 2 years after the date of the most recent unlawful~~
28 ~~practice.]~~ **described in subsection 4**, annual leave time, sick leave
29 time or pay, other fringe benefits and seniority, with interest thereon
30 from the date of the Commission's decision at a rate equal to the
31 prime rate at the largest bank in Nevada, as ascertained by the
32 Commissioner of Financial Institutions, on January 1 or July 1, as
33 the case may be, immediately preceding the date of the
34 Commission's decision, plus 2 percent. The rate of interest must be
35 adjusted accordingly on each January 1 and July 1 thereafter until
36 the judgment is satisfied.

37 **(3) In cases involving an unlawful employment practice,**
38 **pay the costs and reasonable attorney's fees incurred by the**
39 **aggrieved person to pursue the claim.**

40 **(4) In cases involving an unlawful employment practice**
41 **relating to discrimination on the basis of sex, pay an amount**
42 **determined to be appropriate by the Commission as compensatory**
43 **damages or, if the Commission determines that the employer acted**
44 **with malice or reckless indifference, punitive damages.**



1 (5) *In cases involving an unlawful employment practice*
2 *that the Commission determines was willful, pay a civil penalty of:*

3 (I) *For the first unlawful employment practice that the*
4 *person has engaged in during the immediately preceding 5 years*
5 *which the Commission determines was willful, not more than*
6 *\$10,000.*

7 (II) *For the second unlawful employment practice that*
8 *the person has engaged in during the immediately preceding 5*
9 *years which the Commission determines was willful, not more*
10 *than \$15,000.*

11 (III) *For the third and any subsequent unlawful*
12 *employment practice that the person has engaged in during the*
13 *immediately preceding 5 years which the Commission determines*
14 *was willful, not more than \$25,000.*

15 4. *For the purposes of subparagraph (2) of paragraph (b) of*
16 *subsection 3, the period for back pay must not exceed a period*
17 *beginning 2 years before the date on which the complaint was*
18 *filed and ending on the date the Commission issues an order*
19 *pursuant to paragraph (b) of subsection 3 addressing all unlawful*
20 *practices which occur during that period and which are similar or*
21 *related to an unlawful practice in the complaint.*

22 5. The order of the Commission is a final decision in a
23 contested case for the purpose of judicial review. If the person fails
24 to comply with the Commission's order, the Commission shall
25 apply to the district court for an order compelling such compliance,
26 but failure or delay on the part of the Commission does not
27 prejudice the right of an aggrieved party to judicial review. The
28 court shall issue the order unless it finds that the Commission's
29 findings or order are not supported by substantial evidence or are
30 otherwise arbitrary or capricious. If the court upholds the
31 Commission's order and finds that the person has violated the order
32 by failing to cease and desist from the unlawful practice or to make
33 the payment ordered, the court shall award the aggrieved party
34 actual damages for any economic loss and no more.

35 ~~{5-}~~ 6. After the Commission has held a public hearing and
36 rendered a decision, the complainant is barred from proceeding on
37 the same facts and legal theory before any other administrative body
38 or officer.

39 Sec. 3. Chapter 613 of NRS is hereby amended by adding
40 thereto a new section to read as follows:

41 1. *Except as otherwise provided in subsection 2, it is an*
42 *unlawful employment practice for an employer to discriminate*
43 *against any of his or her employees or applicants for employment,*
44 *for an employment agency to discriminate against any person, or*
45 *for a labor organization to discriminate against any member*

1 *thereof or applicant for membership, because the employee,*
2 *applicant, person or member, as applicable, has inquired about,*
3 *discussed or disclosed his or her wages or the wages of another*
4 *employee, applicant, person or member.*

5 2. *The provisions of subsection 1 do not apply to an*
6 *employee, applicant, person or member who has access to*
7 *information about the wages of other employees, applicants,*
8 *persons or members as part of his or her essential job functions*
9 *and discloses that information to a person who does not have*
10 *access to that information unless the disclosure is in response to a*
11 *charge, complaint or investigation for a violation of NRS 613.330.*

12 Sec. 4. NRS 613.310 is hereby amended to read as follows:

13 613.310 As used in NRS 613.310 to 613.435, inclusive, **and**
14 **section 3 of this act**, unless the context otherwise requires:

15 1. "Disability" means, with respect to a person:

16 (a) A physical or mental impairment that substantially limits one
17 or more of the major life activities of the person, including, without
18 limitation, the human immunodeficiency virus;

19 (b) A record of such an impairment; or

20 (c) Being regarded as having such an impairment.

21 2. "Employer" means any person who has 15 or more
22 employees for each working day in each of 20 or more calendar
23 weeks in the current or preceding calendar year, but does not
24 include:

25 (a) The United States or any corporation wholly owned by the
26 United States.

27 (b) Any Indian tribe.

28 (c) Any private membership club exempt from taxation pursuant
29 to 26 U.S.C. § 501(c).

30 3. "Employment agency" means any person regularly
31 undertaking with or without compensation to procure employees for
32 an employer or to procure for employees opportunities to work for
33 an employer, but does not include any agency of the United States.

34 4. "Gender identity or expression" means a gender-related
35 identity, appearance, expression or behavior of a person, regardless
36 of the person's assigned sex at birth.

37 5. "Labor organization" means any organization of any kind, or
38 any agency or employee representation committee or plan, in which
39 employees participate and which exists for the purpose, in whole or
40 in part, of dealing with employers concerning grievances, labor
41 disputes, wages, rates of pay, hours of employment or other
42 conditions of employment.

43 6. "Person" includes the State of Nevada and any of its
44 political subdivisions.



1 7. "Sexual orientation" means having or being perceived as
2 having an orientation for heterosexuality, homosexuality or
3 bisexuality.

4 **Sec. 5.** NRS 613.320 is hereby amended to read as follows:

5 613.320 1. The provisions of NRS 613.310 to 613.435,
6 inclusive, **and section 3 of this act** do not apply to:

7 (a) Any employer with respect to employment outside this state.

8 (b) Any religious corporation, association or society with
9 respect to the employment of individuals of a particular religion to
10 perform work connected with the carrying on of its religious
11 activities.

12 2. The provisions of NRS 613.310 to 613.435, inclusive, **and**
13 **section 3 of this act** concerning unlawful employment practices
14 related to sexual orientation and gender identity or expression do not
15 apply to an organization that is exempt from taxation pursuant to 26
16 U.S.C. § 501(c)(3).

17 **Sec. 6.** NRS 613.340 is hereby amended to read as follows:

18 613.340 1. It is an unlawful employment practice for an
19 employer to discriminate against any of his or her employees or
20 applicants for employment, for an employment agency to
21 discriminate against any person, or for a labor organization to
22 discriminate against any member thereof or applicant for
23 membership, because the employee, applicant, person or member, as
24 applicable, has opposed any practice made an unlawful employment
25 practice by NRS 613.310 to 613.435, inclusive, **and section 3 of**
26 **this act**, or because he or she has made a charge, testified, assisted
27 or participated in any manner in an investigation, proceeding or
28 hearing under NRS 613.310 to 613.435, inclusive ~~{ }~~, **and section 3**
29 **of this act.**

30 2. It is an unlawful employment practice for an employer, labor
31 organization or employment agency to print or publish or cause to
32 be printed or published any notice or advertisement relating to
33 employment by such an employer or membership in or any
34 classification or referral for employment by such a labor
35 organization, or relating to any classification or referral for
36 employment by such an employment agency, indicating any
37 preference, limitation, specification or discrimination, based on race,
38 color, religion, sex, sexual orientation, gender identity or expression,
39 age, disability or national origin, except that such a notice or
40 advertisement may indicate a preference, limitation, specification or
41 discrimination based on religion, sex, sexual orientation, gender
42 identity or expression, age, physical, mental or visual condition or
43 national origin when religion, sex, sexual orientation, gender
44 identity or expression, age, physical, mental or visual condition or

3 **Sec. 7.** NRS 613.350 is hereby amended to read as follows:

4 613.350 1. It is not an unlawful employment practice for an
5 employer to hire and employ employees, for an employment agency
6 to classify or refer for employment any person, for a labor
7 organization to classify its membership or to classify or refer for
8 employment any person, or for an employer, labor organization or
9 joint labor-management committee controlling apprenticeship or
10 other training or retraining programs to admit or employ any person
11 in any such program, on the basis of his or her religion, sex, sexual
12 orientation, gender identity or expression, age, disability or national
13 origin in those instances where religion, sex, sexual orientation,
14 gender identity or expression, age, physical, mental or visual
15 condition or national origin is a bona fide occupational qualification
16 reasonably necessary to the normal operation of that particular
17 business or enterprise.

18 2. It is not an unlawful employment practice for an employer to
19 fail or refuse to hire and employ employees, for an employment
20 agency to fail to classify or refer any person for employment, for a
21 labor organization to fail to classify its membership or to fail to
22 classify or refer any person for employment, or for an employer,
23 labor organization or joint labor-management committee controlling
24 apprenticeship or other training or retraining programs to fail to
25 admit or employ any person in any such program, on the basis of a
26 disability in those instances where physical, mental or visual
27 condition is a bona fide and relevant occupational qualification
28 necessary to the normal operation of that particular business or
29 enterprise, if it is shown that the particular disability would prevent
30 proper performance of the work for which the person with a
31 disability would otherwise have been hired, classified, referred or
32 prepared under a training or retraining program.

33 3. It is not an unlawful employment practice for an employer to
34 fail or refuse to hire or to discharge a person, for an employment
35 agency to fail to classify or refer any person for employment, for a
36 labor organization to fail to classify its membership or to fail to
37 classify or refer any person for employment, or for an employer,
38 labor organization or joint labor-management committee controlling
39 apprenticeship or other training or retraining programs to fail to
40 admit or employ any person in any such program, on the basis of his
41 or her age if the person is less than 40 years of age.

42 4. It is not an unlawful employment practice for a school,
43 college, university or other educational institution or institution of
44 learning to hire and employ employees of a particular religion if the
45 school or institution is, in whole or in substantial part, owned,

1 supported, controlled or managed by a particular religion or by a
2 particular religious corporation, association or society, or if the
3 curriculum of the school or institution is directed toward the
4 propagation of a particular religion.

5 5. It is not an unlawful employment practice for an employer to
6 observe the terms of any bona fide plan for employees' benefits,
7 such as a retirement, pension or insurance plan, which is not a
8 subterfuge to evade the provisions of NRS 613.310 to 613.435,
9 inclusive, **and section 3 of this act** as they relate to discrimination
10 against a person because of age, except that no such plan excuses
11 the failure to hire any person who is at least 40 years of age.

12 6. It is not an unlawful employment practice for an employer to
13 require employees to adhere to reasonable workplace appearance,
14 grooming and dress standards so long as such requirements are not
15 precluded by law, except that an employer shall allow an employee
16 to appear, groom and dress consistent with the employee's gender
17 identity or expression.

18 7. **For the purpose of subsection 1, the term "bona fide**
19 **occupational qualification reasonably necessary to the normal**
20 **operation of that particular business or enterprise" does not**
21 **include:**

22 (a) **A qualification which is based upon or derived from a**
23 **difference on the basis of sex; or**

24 (b) **A qualification that the employer, employment agency,**
25 **labor organization or joint labor-management committee has**
26 **refused to change after an affected person has presented an**
27 **alternative practice that would serve the same purpose without**
28 **producing the same amount of differential treatment on the basis**
29 **of sex.**

30 Sec. 8. NRS 613.380 is hereby amended to read as follows:

31 613.380 Notwithstanding any other provision of NRS 613.310
32 to 613.435, inclusive, **and section 3 of this act**, it is not an unlawful
33 employment practice for an employer to apply different standards of
34 compensation, or different terms, conditions or privileges of
35 employment pursuant to a bona fide seniority or merit system, or a
36 system which measures earnings by quantity or quality of
37 production or to employees who work in different locations, if those
38 differences are not the result of an intention to discriminate because
39 of race, color, religion, sex, sexual orientation, gender identity or
40 expression, age, disability or national origin, nor is it an unlawful
41 employment practice for an employer to give and to act upon the
42 results of any professionally developed ability test, if the test, its
43 administration or action upon the results is not designed, intended or
44 used to discriminate because of race, color, religion, sex, sexual

3 **Sec. 9.** NRS 613.390 is hereby amended to read as follows:

4 613.390 Nothing contained in NRS 613.310 to 613.435,
5 inclusive, **and section 3 of this act** applies to any business or
6 enterprise on or near an Indian reservation with respect to any
7 publicly announced employment practice of such business or
8 enterprise under which a preferential treatment is given to any
9 individual because the individual is an Indian living on or near a
10 reservation.

11 **Sec. 10.** NRS 613.400 is hereby amended to read as follows:

12 613.400 Nothing contained in NRS 613.310 to 613.435,
13 inclusive, **and section 3 of this act** requires any employer,
14 employment agency, labor organization or joint labor-management
15 committee subject to NRS 613.310 to 613.435, inclusive, **and**
16 **section 3 of this act** to grant preferential treatment to any person or
17 to any group because of the race, color, religion, sex, sexual
18 orientation, gender identity or expression, age, disability or national
19 origin of the individual or group on account of an imbalance which
20 exists with respect to the total number or percentage of persons of
21 any race, color, religion, sex, sexual orientation, gender identity or
22 expression, age, disability or national origin employed by any
23 employer, referred or classified for employment by any employment
24 agency or labor organization, admitted to membership or classified
25 by any labor organization, or admitted to, or employed in, any
26 apprenticeship or other training program, in comparison with the
27 total number or percentage of persons of that race, color, religion,
28 sex, sexual orientation, gender identity or expression, age, disability
29 or national origin in any community, section or other area, or in the
30 available workforce in any community, section or other area.

32 613.405 Any person injured by an unlawful employment

34 **section 3 of this act** may file a complaint to that effect with the
35 Nevada Equal Rights Commission if the complaint is based on
36 discrimination because of race, color, sex, sexual orientation, gender
37 identity or expression, age, disability, religion or national origin.

38 **Sec. 12.** NRS 613.420 is hereby amended to read as follows:

39 613.420 If the Nevada Equal Rights Commission does not
40 conclude that an unfair employment practice within the scope of
41 NRS 613.310 to 613.435, inclusive, **and section 3 of this act** has
